RULES FOR BOOTHS

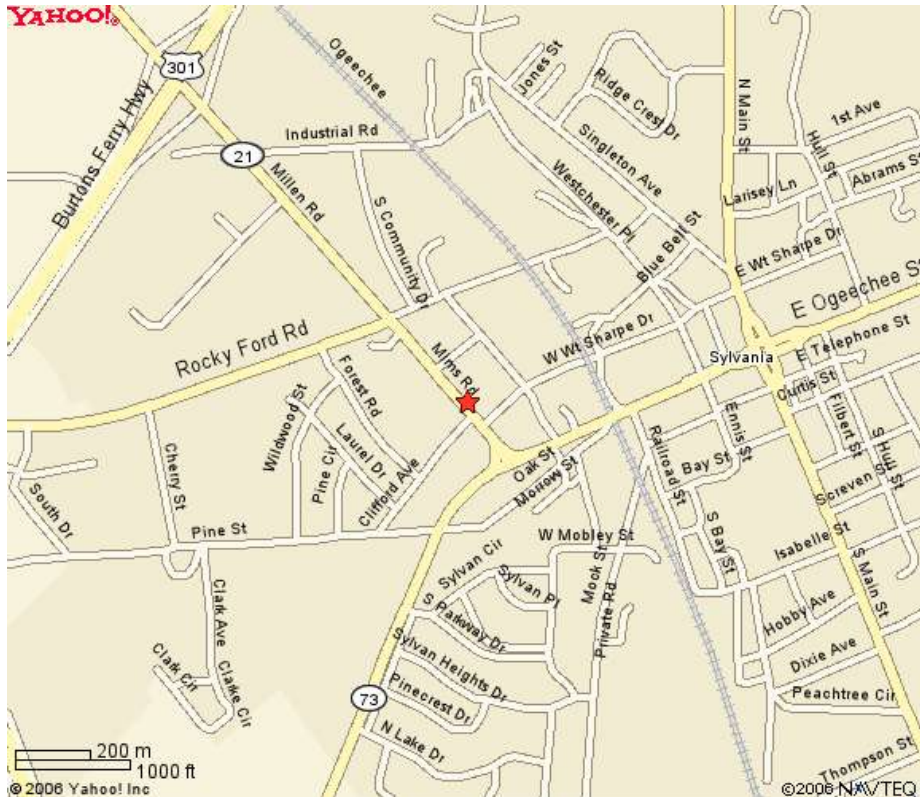
1. An entry fee of \$25.00 per space will be charged for all booths selling merchandise or food. There is no fee for nonprofit information only booths. All other information booths and nonprofit booths that are selling merchandise or food will be charged an entry fee of \$15.00. The entry fee will reserve a space of approximately 15' x 15'.
2. Fees must be made payable to the Sylvania Junior Woman's Club and must be received no later than September 16, 2009.
3. Exhibitors will receive notification ONLY if no spaces are available. Money for booth rental will be returned at that time. If you would like written confirmation prior to the date of the SAMPLER, please include a stamped, self-addressed envelope with your registration.
4. Exhibitors may set up between 8:00 a.m. and 9:30 a.m. on the day of the Sampler. Vehicles will not be allowed on the grounds after 9:30 a.m. Reserved exhibitor parking is available before 9:30. Spaces on the crafts ground area will be marked off and exhibitors will be assigned on a first come basis as they arrive on Saturday.
5. Exhibitors must provide all tables and other equipment to display their merchandise. Exhibitors are encouraged to bring a tent for shade.
6. Exhibitors will be responsible for setting up and cleaning up their own booth areas. All paper, trash and other materials must be cleaned from the area immediately following the fair. Vehicles will not be allowed back on the grounds until 4:00 p.m.
7. Exhibitors may not damage or destroy the property or trees in any manner.
8. All entries are subject to review and dismissal by the Sylvania Junior Woman's Club and fees received after the September 16 deadline may be subject to dismissal.
9. Bathrooms are available. No electricity is available for booths.
10. The Sylvania Junior Woman's Club is not liable for any injuries sustained during the Sampler.
11. **The Sylvania Junior Woman's Club has exclusive rights to the sale of bottled water.**
